1. <b>9:00</b>	Dispute between <b>CPR</b> and <b>TCRC-CTY-E</b> concerning the failed accommodation to conductor M.S> between the dates of September 5, 2018 until October 22, 2018 and November 9, 2018 to November 12, 2018. (COUNSEL)
2. <b>10:00</b>	Dispute between <b>CPR</b> and <b>TCRC-CTY-E</b> concerning the dismissal of Utility Foreman T.C. for failing a post incident drug screen where there was a Positive Urine Drug Test that was administered on January 9, 2018, while working on Assignment UTIL1 as Utility Person on January 9, 2018). (COUNSEL)
3. <b>11:00</b>	Dispute between <b>CPR</b> and <b>TCRC-LE-W</b> concerning Locomotive Engineers in Revelstoke with regard to the violation of the Golden Zone Agreement and Article 30.11 of the current Collective Agreement. (COUNSEL)
4. <b>13:00</b>	Dispute between <b>CPR</b> and <b>TCRC-CTY-W</b> concerning B.M. and the assessment of a 7-day suspension for failure to report your injury to a manager in a timely manner, and further failure to report to a manager the intent to seek medical attention on May 2, 2016 after being advised to do so a violation of T&E Safety Rule Book CORE Safety Rules Item 1 Rights and Responsibilities.
5. <b>14:00</b>	Dispute between <b>CPR</b> and <b>TCRC-CTY-W</b> concerning B.M. and the assessment of a 5-day suspension for booking off sick after accepting the K36 assignment call for duty. A violation of CP's attendance Management Policy. (COUNSEL)
6. <b>15:00</b>	Dispute between <b>CPR</b> and <b>TCRC-CTY-W</b> concerning B.M. and the assessment of a 20-day suspension for failure to fulfill his contractual obligation as evidenced by booking unfit on October 5, 6, and 7, 2017. (COUNSEL)
7. <b>16:00</b>	Dispute between <b>CPR</b> and <b>TCRC-CTY-W</b> concerning the dismissal of B.M. for failure to fulfill contractual obligations as evidenced by exhibiting patterned absenteeism on three occasions with two instances occurring on weekends. (COUNSEL)

9. <b>10:00</b>	Dispute between <b>CPR</b> and <b>USW-1976</b> concerning M.W. and the assessment of a 10-day suspension without pay and a 10-day deferred suspension for failure to obey traffic sign during the tour of duty on January 8, 2018.
10. <b>11:00</b>	Dispute between <b>CPR</b> and <b>MWED</b> concerning the discharge of J.M. for a Rule G violation after the Company received a post-accident non-negative substance result that was supplied after an incident that occurred while he was a passenger in a company vehicle.

A violation of CROR Rule G. (COUNSEL)
12. 14:00	Dispute between <b>CPR</b> and <b>MWED</b> concerning the discharge of R.K. for a positive post incident drug test that was supplied to the Company following an incident at crossing mile 61.5 Cascade Sub – A violation of HR Procedure HR 203 and CRO Rule G. (COUNSEL)
13. 15:00	Dispute between <b>Ontario Northland</b> and <b>UNIFOR-LOCAL-103</b> concerning the assessment of 60 demerits and subsequent discharge of Engine Attendant L.M. for a positive breath alcohol test the morning of duty.
