1. 09:00	Dispute between CNTL and UNIFOR concerning the application of Schedule B of the Standard Contract between Owner-Operators who are members of Unifor National Council 4000 and contractors with Canadian National Transportation Ltd.
2. 10:00	Dispute between CNTL and UNIFOR concerning the two day suspension imposed on L.F. for missing forty-six days of work and requesting early finals while at work seventy-four times over a 242 day period from January 1, 2016 to December 14, 2016.
3. 11:00	Dispute between CNTL and UNIFOR concerning the termination of L.F. for failing to fulfill his obligations under the Standard Contract between January 1, 2017 to July 19, 2017.
4. 13:00	Dispute between CM&QR and USW-Local-1976 concerning the assessment of twenty-two day suspension to S.R. for an alleged act of insubordination.
